SECTION VI: AWARDS AND FINANANCIAL ASSISTANCE

ASSISTANTSHIPS

Assistantships (merit awards) are awarded only tetifrulle Ph.D. students (taking 9 credit hours each semester), and provide academic year stipend 26% 000. Additionally, graduate assistants receive a tuition fellowship covering 21 hours per academent. Graduate assistants are assigned relevant professional work for no more than 20 hours per week. Merit awards are awarded on an annubasis and can be extended to a total of viewers as long as students are making good progress in the program.

DIVERSIFYING HIGHER EDUCATION FACULTY IN ILLINOIS FELLOWSHIPS

Students who have (1) belong to an underrepresented minority group, (2) obtained a high school or postsecondary degree in Illinois, and (3) have three years of residency in Illinois may apply. Recipients are required to work in higher education or education administration in Illinois upon graduation to avoid partial regrament. The fellowship provides two years of an MA program or up to four years of a doctoral program.

ATTOH GRADUATE DIVERSITY FELLOWSHIP

Incoming students from underrepresented minority groups may be nominated by the department for this award, which provides stipend and scholarship support and a \$500 annual professional development stipend. Awards are limited to U.S. citizens, permanent residents, or DACA recipients and renewable for two years for MA students and five years for doctoral students.
